FROM YOUR PRESIDENT

It's winter again at the Shores as we start a new year almost a decade into the 21st Century.

During 2008 we took a vote on whether or not to dedicate the roads to Brick in order to induce them to pave our streets. The vote, as we previously reported, was in favor of the dedication. We sent a letter to Brick indicating our willingness to dedicate the streets. The town council voted to accept the dedication but that is as far as it has gone. Our attorney advised us that without signing a deed to the Township no transfer has taken place.

The paving of the streets took place this past spring. The Association and the Township have come up with a number of items that the paving contractor did not complete. The Township and the Association had believed that the unfinished work would be done before the end of 2008, but that didn't happen. Brick is holding approximately \$85,000 as a retention to guarantee that the contractor finish the punch list items.

The MSPOA Annual Classic Soiree held at Ebby's North was again a success with over 100 people attending.

Elsewhere in the Newsletter is an article about the Nominating Committee. As I have stated many times in these pages, we are constantly looking for people to help. Right now we need someone who could take over the Secretary position and someone for the Treasurer position. These positions offer no pay and no fringe benefits – only the satisfaction of contributing to keep Mantoloking Shores the special place that it is, and working with a wonderful group of your neighbors. If you have some time and are willing to give something back to the Community, please contact a member of the Nominating Committee.

Although the Membership Secretary Patrick Tuohy mentioned in his article the need to provide contact information, I want to restate it here since it is really important for us to get information to you on a timely basis and to be able to reach you in the event of an emergency. Please provide us with your telephone numbers and e-mail address, and when you change e-mail address be sure to include us to the list of people you notify about that change. Also, we plan to send out e-mails when the Newsletter is posted to the website.

A word of caution ... last summer we had a college age young lady selling books door to door. She said her family owned a home in the Community (gave a last name and a street) and that she was selling books to help defray the cost of taking some college courses in Europe. Checking the name and the address, it was discovered that this was a scam .. her family did not own a home here. She was a professional salesperson. Saying she was a neighbor and a college student was a ruse to make sales. Please be careful who you let into your home. Brick has a law that requires all door to door solicitors to have a permit from the town and must show it to you when asked.

Lastly, some good news on the expense front. We were able to cut our insurance cost in half by taking the insurance to a new broker and combining the Liability and the Directors & Officers insurance into one policy.

NOTES ON FINANCIAL STATEMENT

- **NON-BUDGET ITEMS**: The Address Book gave us \$1,100.40; the Annual Party gave us \$2.10; Pennants, Tee Shirts and Sweatshirts gave us \$184.49 for unanticipated total of \$1,296.99
- **BUDGET ITEMS**: Gave us a loss of \$2,400 in DUES from 16 anticipated but non-dues paying "members"
- **Interest** was down \$182.72 partly because we had to withdraw money which took the principle below \$50,000 so the per cent interest rate also dropped. Also a banking rate drop
- **Insurance** found a large savings. With a new agent, we are paying about one-half the previous amount for the total package
- NJ Sales Tax was \$215.36 under what the Budget Committee anticipated
- **Utilities** (Electric, Water and Sprinkler Maintenance) were \$169.66 below the anticipated amount
- Cutter Lane Bulkhead still needs repair so look for it next year again
- **Supplies** were under spent by \$288.01
- **Professional Services** were not needed for Electric or Water systems; thus saving \$1,000
- **Property Upkeep** was \$1,300 lower than predicated
- **Recognitions** were less than anticipated by \$142.02. We did not have anticipated changes
- **Damaged Signs** were none so we did not spend the \$300 anticipated
- **Lagoon End Beautification** we have a contract that is not complete and we have \$3,350 remaining
- **Extraordinary** we have \$8,500 untouched. The streets have not been taken by Brick Township as of the end of the year
- **Legal** unexpected needed and overshot the Budge by \$2,554,50
- Contributions were not fully used because we never were asked to contribute. The Treasurer pays bills and does not give unsolicited; we donated to Save Barnegat Bay and Pioneer Hose Company No. 1
- **Office Supplies** were under budget by \$1,267.29
- **NET INCOME** of \$7,013.36 in spite of spending \$7,079.36 more than budgeted leaving us with the Total Assets shown below:

FINANCIAL SECRETARY & MEMBERSHIP OFFICER REPORT

My name is Patrick Tuohy and I have been asked to write a brief article describing the responsibilities of my position. This position is one of the five Officer positions on the Board of Trustees of the Mantoloking Shores Property Owners Association (MSPOA).

My job is to keep a complete updated record of all property owners of Mantoloking Shores. This includes both summer and winter addresses, phone numbers and emails. Why? In case there is any reason you need to be contacted immediately, for example, if you are away and there is water running, a water heater breaks, a break-in occurs or, any number of emergencies which might necessitate getting in immediate contact with you.

In addition to keeping a complete list of all homeowners, I keep a complete record of who has been paying dues to the MSPOA over the past years and when they are paid. This involves keeping an updated dues list so it can also be used for budgeting purposes.

The MSPOA has completed numerous projects over the past several years which benefit all of the owners of Mantoloking Shores. For example, all of the common bulkheads have been replaced over the past several years. This is an expense that would be impossible without the support of the entire Mantoloking Shores homeowners.

In addition, the Association provides dues paying members with liability insurance for the streets of MSPOA. However, you are only covered by this insurance if you pay your annual dues. Last year, the Beautification Committee planned, hired and is in the final stages of completing plantings on the common bulkheads to create a more pleasant appearance on these sites for everyone to enjoy.

In addition to these specific projects, there are ongoing expenses for a Landscaper to care for the Center Island where the flagpole stands, and the common grounds on Rt. 35 South and the ends of the Lagoons which are not leased or owned. We also pay to have any garbage or recycling receptacles put away from the streets if you are not down at MS after the town pick-ups. Finally, if any legal matters arise where MSPOA needs to seek legal counsel, money is required to retain and pay for these services.

A list of names of the homeowners who supported MSPOA in 2008 is listed on the following page. Of 308 residents, 239 are paid members of MSPOA. The Association thanks you for your support. If you are not listed, we hope you will find it within your means to pay the \$150.00 dues fees for 2009 because everyone's support is critical towards making Mantoloking Shores a great community to live in.

The Annual Dues for MSPOA are sent out in January each year. The dues slip contains all of the information we have on file for you including your MS address; your winter address is also printed on the dues slip in addition to phone numbers and emails. If any of the information is incorrect, please correct it and, in all cases, please mail back your dues slip with your payment so we can properly credit your payment. We assume your winter address is where we mail the dues unless you tell us otherwise. Thank You.

We have a number of pet owners in our Community and most of them respect the law and other people's property. They don't let their pets deposit their waste, whether solid or liquid, on other homeowner's property or plantings. Solid waste that is not picked up and put into the proper disposal container usually ends up in the lagoon where a lot of us swim. Please, if you own a pet, obey the law; clean up after them; help protect your neighborhood and the water that you paid so much to live in.



The Board is obtaining proposals to see if there isn't something we could do to improve the appearance of the area abutting the Community along Rt 35. Hopefully, we will have something done or, at least, have something to show the membership by the annual meeting.

If you are one of the residents who noticed that the lagoon ends on Bay Lane did not look their best last summer, it is due to the work done by the paving contractor. When the sidewalks were installed on Bay Lane the contractor removed the filter fiber that the Association had had installed to prevent weeds from growing. The paving contractor replaced it with plastic in a very haphazard way. This is one of the items that the contractor will be addressing as they complete their contract.

## FEDERATION OF BEACH ASSOCIATIONS UPDATE

Mark Ellsworth, President of the Federation of Beach Associations reported that they are working on a number of issues:

<u>BEACH REPLENISHMENT</u> - As everyone on the Barrier Island knows the erosion of the beaches threatens us all. One major storm could be catastrophic. The Federation, working with other groups on the island, is trying to get the local state and the federal government to focus on this issue.

<u>POLICE PROTECTION</u> - The Federation continues to work with Brick to have them assign more patrol officers to our area.

<u>CONSOLIDATION OF COMMUNITIES</u> - a state assemblyman has proposed a bill that would consolidate small towns within the state; particularly on the Barrier Islands of Long Beach and Barnegat Bay Island (our island). The Federation is talking to the assemblyman's office and expressing to them the Federation's support on this issue.

### Note:

For the benefit of our new homeowners and those of you who may have forgotten, the Beach Federation is an alliance of all the beach communities on Barnegat Beach Island that are in Brick Township. Formed in 1971, the primary goal of the Federation is to collectively protect and improve the quality of life on our barrier island. The objective of the Federation is to project a strong united voice from the island to Brick.

## SWIMMING POOL OWNERS

We have received several inquires from homeowners with pools asking if there is a way to avoid sewer charges when they are filling their pool.

We have checked and found that there are two methods you can use to avoid sewer charges. One is a temporary method and the other is a permanent resolution to the problem.

- 4 The temporary one is to borrow a meter from the Brick Township Municipal Utilities Authority ... telephone number 732-458-7000. They have meters that can be attached to the hose you use to fill the pool. This meter can be borrowed for a single use and must be returned. They will take the usage recorded on the temporary meter attached to your hose and deduct that reading from your overall water consumption and your sewer charge will be based on the lower reading.
- For the permanent resolution to the problem, you need to contact New Jersey American Water Company ... telephone number 800-652-6987. They will send an engineer out to survey your situation. What they will do is install a second meter that you can use for the pool, and that meter reading will not be part of the reading for the calculation of sewer charges. The person we spoke to stated that the installation charge for the new meter would be in the range of several hundred dollars depending on what it would take to install the new meter. Of course, the plumbing from the new meter to the pool would be the responsibility of the homeowner.
